# Mike McGill-Parent Governor, Nominated Governor for Health & Safety and Safeguarding

### Monitoring, reporting and improving

- Governors meet half termly with their "link Leadership Team member" to monitor the impact of action related to their areas of responsibility, including school priorities
- Records of Visit are shared with all LGB members via Governor Hub and the Principal so appropriate action can be taken.
- Summary of LGB meetings are forwarded to Wensum trustees
- The CEO of Wensum Trust visits school every two weeks to meet with the Principal.
- The Principal attends Operations Board meetings approx. every three weeks with other Wensum Principals, Headteachers and the CEO.
- Collaborative meetings across Wensum Trust schools take place half termly and involve all Leadership Team members and Heads of English, Maths and Science.
